By signing this application, I agree that:

(Please Read and Check the following...)

- All selling activity will be confined to my display area (10' x 10' or 10' x 20') and/or my storefront area and will not extend into the street.
- I will not have any sandwich board signs.
- I will not offer any products for sale that are not routinely sold in my place of business throughout the year, for example: soda, water, candy.
- I will not sell or give away balloons nor have clowns or other attractions in my booth area.
- My display area will be staffed at all times during show hours. No breaking down early.**
- I will not sublet or place any other business or organization in my space.
- No generators will be used and understand that electric is not provided.
- I will be at my establishment by 9:00am Sunday because the road barricade will be up due to Main Street closing.

Booth Presentation:

- Merchants will provide their own display booth, racks or tables for their work to be properly displayed and boxes and packing crates will not be visible. (If you would like assistance with ideas/design for your display, you may contact FPMA Merchant Joanne Sharpe, from Art & Soul at 223-4560).
- All non-Main St. Merchants will be placed in an advertised merchant location in the Village Landing lot.
- Merchants are encouraged to be prepared for any inclement weather with appropriate rain covers, tie downs and weights. Spikes are not allowed.
- The Village of Fairport, the Fairport-Perinton Merchants Association Inc. and individual merchants will not be held responsible for any theft, loss of property or personal injury suffered during or as a result of participation in Fairport Canal Days.

FPMA Bylaws excerpt:

Classes A, B, & C members shall have full voting power. Class A&B members shall be entitled to hold office. Class A members shall be eligible to participate in Canal Days provided the Canal Days application has been postmarked by March 15th. Class B & C shall be eligible for Canal Days privileges when juried by the Artisan Committee or approved by the Food Committee. Class D is not eligible for Canal Days privileges.

All members shall be eligible to participate in all other programs and activities sponsored by the FPMA.
