## **What is Fairport Canal Days?**

Fairport Canal Days is a two-day annual Arts and Crafts Festival featuring 200+ artisans, along with food vendors, children's activities and live entertainment, held the first full weekend in June in the Village of Fairport, New York along the Erie Canal.

Friday is the kick off to the weekend with BBQ and a premier Rochester area band. **(No artisan set up)**

Fairport is an eastern suburb of Rochester located in central western New York and is one of the showcase stops for boats traveling the historic Erie Canal. Boat cruises along the Erie Canal add to the festive atmosphere. Canal Days has become one of the premier events in the Northeast, attracting over 200,000 visitors each year.

# Artisan Application and Instructions

## Festival Requirements & Information

- All work displayed must be consistent with photos submitted with the application. Compliance will be verified during the festival.
- Exhibitors displaying buy/sell items will be immediately dismissed.
- Each exhibitor will be assigned a 10' wide x 10' deep space (not tent).
- Be prepared for any kind of weather, especially winds! Come with rain covers, tie downs, and weights. Spikes are not allowed! Bring levelers, some sidewalks are uneven.
- No generators allowed. Electric is not available.
- The Committee attempts to honor specific space location requests, but no guarantees can be made.
- Only one artist may exhibit in each space. Two may share with prior approval of committee.
- Must be registered with the State of New York and display "Certificate of Authority". Artists are responsible for collection and payment of 8% local sales tax. For tax info: visit [www.tax.state.ny.us](http://www.tax.state.ny.us) (form DTF-17)
- Limited corner spaces are available for an additional fee of \$25. If a corner is not available, the \$25 will be refunded at the show.
- Demonstrate in your booth! We identify as such, with your booth location, in our promotional materials. (5' additional space can be made available, please note on application)

**Insurance Certificates:** Required for all accepted Interactive Activities. ie: children's activities...

- **THREE PHOTOS OF YOUR WORK**
- **ONE PHOTO OF CREATING YOUR WORK**  
(Automatic denial if not submitted)
- All photos must be consistent with work in booth. Compliance will be verified during the festival.
- The four photos are to be submitted with the application in either print or CD form or uploaded digitally on the website.
- Include an appropriate size self-addressed stamped envelope (SASE) with 84¢ postage for return of the photos. Photos will not be returned if you do not include a SASE. CD's will not be returned without proper size SASE and postage.

## Selection Process

We are a juried arts and crafts festival, with approximately 200 available spaces. Acceptance is based on the **quality**

**and originality** of work as represented by the submitted photos. Jurying will continue with use of your submitted photos to cross reference throughout the festival weekend. **Decisions of the panel are final.**

## Young Emerging Artists (Under 25)

- Application/Booth Fee: \$25 Total!
- Submit a copy of your School ID or License along with all other application requirements.
- If accepted, an Emerging Artist Seminar is mandatory to participate (scheduled tentatively Spring 2012) Seminar highlights will include: pricing, presentation/display tips, promotional materials, etc.
- Option II: 2 to 3 artists per booth (Share responsibilities of manning booth). At least one artist must be present at all times.
- 13 Juried Booth spaces available in Box Factory
- Two year participation limit
- Award given to top artist for craft & presentation!

## Local Art Groups

- One Booth Fee/per Art Group!
- Application Fee Only per artisan in group
- Complete an application for each artisan representing your group. (names will be listed in our promotional materials)
- A banner or sign hung in booth identifying the name of group/association

## Fees

Each application must be accompanied by application and booth fees. If you apply on-line through our website, you may pay with Master Card or Visa. If you mail in your application please include **checks payable to FPMA Inc.:**

- One check for the non-refundable \$25 application fee
- One check for booth fees (\$260.00 for one booth or receive a (2) two booth discount - \$495)
- If requesting a corner booth, please include a separate check for \$25.
- Any application postmarked after February 1, 2012, must include a non-refundable late fee check of \$50.00, otherwise the application will be returned unprocessed

**Applications Mailed In:** Any application fee and late fee checks will be deposited upon receipt. The booth fee check will be returned to applicants who are not accepted in the festival. If you are accepted to the festival, any booth and corner fee checks will be *deposited upon acceptance to the festival.*

**Applications Submitted Online:** Payment is accepted at time of application. The booth fees and corner fee if submitted will be refunded to applicants who are not accepted for the festival.

## Also:

- Any checks returned for Insufficient Funds will result in applicant rejection.
- No refunds will be made after April 30th or for removal of cause.
